2017 TERMS AND CONDITIONS

RESPONSIBILITY: Alaska Motorhome Rentals is a division of Alaska Travel Adventures, Inc. ATA is headquartered at: 9085 Glacier Highway, Suite #301, Juneau, Alaska 99801.

RESERVATIONS: When making reservations through a travel agent your deposits and final payments for ATA services will be paid to the travel agent. Travel documents shall be issued after final payment has been received by ATA. Refunds will be made to the travel agency less any applicable fees, deposits and charges. Guests are responsible for obtaining from their travel agency monies retained or received by the agency.

DEPOSITS AND FINAL PAYMENTS: A deposit of \$500 per RV is due within 7 days from date of reservation confirmation. Final payment is due 30 days prior to date of RV pick up for round trip rentals and 60 days prior to date of RV pick up for one-way rentals. All payments must be made in U.S. funds by Visa, MasterCard, Discover Card, American Express or either check or money order made payable and mailed to: Alaska Travel Adventures, Inc., 9085 Glacier Highway, Ste 301, Juneau, AK 99801

INTERNET AND BROCHURE RATES: All rates are in U.S. dollars.

RENTAL SIZES: Standard size motorhomes are 21 to 24-feet in length. Large size motorhomes are 28 to 31-feet in length.

ANCHORAGE SUNDAY SAVINGS: For rentals either picked up dropped off in Anchorage on a Sunday, deduct \$2.00 per day from the rate table above. For rentals that are both picked up and dropped off in Anchorage on a Sunday deduct \$4.00 per day.

MILEAGE CHARGES: If the unlimited mileage option is not purchased mileage is charged at the rate of \$.35 per mile plus applicable tax.

UNLIMITED MILEAGE OPTION: Add \$39.00 per day to the rate tables in the brochure or online, plus applicable tax.

ANCHORAGE VEHICLE RENTAL TAX: Municipality of Anchorage vehicle rental tax of 8% applies to all rentals originating in Anchorage. Tax applies to rental rates and mileage charges as well as one-way drop fees, if applicable, up to a maximum of \$240.00 per consecutive rental period.

ALASKA VEHICLE RENTAL TAX: State of Alaska RV rental tax of 3% applies to all rentals originating in Alaska. The tax applies to rental rates and mileage charges.

PICK UP AND DROP OFF LOCATIONS: Anchorage, Alaska; Fairbanks, Alaska; Skagway, Alaska and Seattle, Washington.

RV PICK UP AND DROP OFF TIMES: Motorhomes will be available for pick up between 2:00 pm and 5:00 pm on the day the RV land tour commences. Vehicles will be vacated between 7:00 am and 9:00 am. Vehicles may be obtained at times other than stated, subject to availability. Additional fees shall apply.

PETS, EXTERIOR STORAGE AND TOWING: With prior approval, the accommodations for pets, exterior storage and towing may be arranged. If granted, additional charges shall apply.

OPTIONAL EQUIPMENT RENTAL: Lawn chairs, barbecues, car seats, coolers, TV/DVD combos, bicycles, bicycle carriers and generators are available for rent at an additional charge.

HOUSEKEEPING PACKAGE: "Housekeeping Package" is \$35 per person, per rental, and includes bedding (sheets, pillowcases, blankets, pillows) towels, eating, cooking, and storage ware.

UPGRADES AND SUBSTITUTIONS: ATA reserves the right to upgrade a guest to superior RV accommodations at no additional cost. Should lesser equipment be offered and accepted, AMR's liability to the customer shall be limited to a refund of the price differential.

MINIMUM RENTAL PERIOD: The standard minimum rental period is four rental days (4 nights). Longer minimum rental periods may be established from time to time without prior notification.

IMMIGRATION: If traveling into Canada, U.S. and Canadian citizens must carry a valid passport. For non-U.S. citizens who have previously been admitted to the U.S. for permanent residence, and who will be returning to the U.S., no reentry permit is required. However, these guests must carry their passport and Alien Registration Receipt Card (I-551). Citizens/residents of other countries should consult their local American and Canadian embassies, consular offices, or immigration offices for entry and exit requirements. GUESTS WITH DISABILITIES: ATA's motorhomes are not equipped for disabled access.

DEPOSITS AND FINAL PAYMENTS

A deposit of \$500 per RV is due within 7 days from date of reservation confirmation. Final payment is due 30 days prior to date of RV pick up for round trip rentals and 60 days prior to date of RV pick up for one-way rentals.

CANCELLATION FEES: The following cancellation fees apply for motorhomes picked up and dropped off at the same location:

- If canceled after reservation is confirmed by deposit, but 61 or more days prior to first day of rental – Full refund less \$50 processing fee and loss of Cancellation Fees Protection payment if applicable.
- If canceled between 31 and 60 days prior to first day of rental - \$250
- If canceled between 16 and 30 days prior to first day of rental - \$350
- If canceled 15 or fewer days prior to first day of rental – No refund

The following cancellation fees apply for one-way motorhome rentals:

- If canceled after reservation is confirmed by deposit, but 91 or more days prior to first day of rental – Full refund less \$50 processing fee.
- If canceled between 61 and 90 days prior to first day of rental - \$250
- If canceled between 46 and 60 days prior to first day of rental - \$350
- If canceled 45 or fewer days prior to first day of rental – No refund

CANCELLATION FEES PROTECTION (CFP): CFP is optional and does not apply to one-way rentals. CFP must be elected at time of reservation and paid for along with deposit. Cost is 10% of the total gross rental rate. The fee shall be based upon the combined daily rental rate less any applicable discounts. Taxes, mileage charges, optional Housekeeping Package, CDW, Windshield Protection, equipment rentals and any other charges or fees are not included when calculating the CFP. CFP protects customers from cancellation fees if cancellations are received in writing by ATA at least 72 hours prior to 12:01 am of the first day of RV rental. The cost for CFP is non-refundable.

INSURANCE DEDUCTIBLE, COLLISION DAMAGE WAIVER (CDW) AND DAMAGE DEPOSIT: Insurance deductible without CDW is \$1,500. Deductible with CDW is \$250. Optional CDW is \$19 per day. Damage deposit with CDW is \$250. Damage deposit without CDW is \$500.

WINDSHIELD DAMAGE PROTECTION: Optional windshield damage coverage is available for purchase at \$12 per day of rental. This coverage will protect customers for charges pertaining to and requiring windshield damage repair or replacement not associated with a collision, rollover, and acts of negligence or reckless driving.

RECREATIONAL VEHICLE INSURANCE: AMR provides comprehensive, collision and liability insurance for its RV's. This insurance, less a \$1500 deductible, will cover incidents involving your RV in much the same manner as your own automobile policy. Details of specific coverage are included in your Rental Agreement. A copy of the Rental Agreement may be obtained by written request to: Alaska Travel Adventures, Inc., 9085 Glacier Highway, Ste 301, Juneau, AK 99801.

RV DAMAGE DEPOSIT: An RV damage deposit of \$500 is required at the time the RV is picked up. Deposit will be charged to a qualifying credit card. Deposits will be fully refundable upon return of the RV in satisfactory condition. Any vehicle damage will be deducted from the deposit and charged to the credit card up to the \$1500 deductible limit. Specific acts of negligence as outlined in the Rental Agreement may increase driver liability for vehicle damage.

RV ROAD RESTRICTIONS: There are various roads in Alaska, Yukon, and British Columbia that are deemed by ATA to be unsuitable for RV travel. These roads will be noted in the Rental Agreement, and unauthorized travel is not covered by your insurance policy.

LATE DROP OFF CHARGES AND OTHER FEES: The RV you drop off will be picked up the same day by other AMR guests. In between, the vehicle requires servicing, provisioning and cleaning. As you will appreciate the timely return of the RV by guests who precede you, we appreciate your consideration for the guests that follow. We reserve the right to impose late drop off fees of \$50 per hour, or fraction thereof, for RV's that are returned or vacated after the specified time. Transfers may be available at an additional charge. Fees shall also be imposed for vehicles returned with less than full gasoline and propane tanks, unclean interiors and exteriors, smoking in vehicles and for undumped holding tanks. Details of these fees are contained in the Rental Agreement.

UNUSED SERVICES: Refunds are not available for unused prepaid excursions or transfers when voluntarily canceled. Requests for valid refunds must be made in writing through your travel agent or to ATA explaining the circumstances of the refund request, applicable dates, and the confirmation number.

RV DRIVER REQUIREMENTS: Drivers must be a minimum of 25 years of age and be in possession of valid drivers license that does not expire during the period of the rental. Drivers are required to complete and sign the company's Rental Agreement.

MINIMUM RENTAL PERIOD: The standard minimum rental period is four rental days (4 nights). Rentals of less than 7 days within the month of July are very limited. It is recommended that requests for rentals less than 7 days during this period be made After May 1, 2017.

NON-SMOKING POLICY: ATA maintains a no smoking policy in its motorhomes.

AIRPORT/HOTEL TRANSFERS: Transfers are \$20 on days of rental pick up and drop off only between the rental depot and Seattle-Tacoma International Airport, Anchorage International Airport, Fairbanks International Airport, Skagway Airport, Anchorage, Fairbanks or Skagway area hotels.
